May kindly see the online requisition dated 25.05.2023 (received online) of Smt. Shiva Pandey, Special Judge (E.C. Act), Pilibhit requesting for inclusion of her Ph.D. Degree in her service records & addition of prefixing the word "Doctor" vide Case Id. No. 30742023. In view of the above, Smt. Shiva Pandey, has furnished her duly attested scanned copies of the Degree Qualification, as supporting document for the same.

An objection dated 27.05.2023 was raised by this office and in reply, Smt. Shiva Pandey, aforesaid has furnished the desired document by attachment dated 27.06.2023.

In this connection, it is submitted that Smt. Shiva Pandey, aforesaid, joined U.P. Judicial Services on 25.03.2021 as Additional District & Sessions Judge, Ayodhya. Besides, as evident from her submitted attested copy of his degree of Ph.D., Smt. Shiva Pandey, was awarded the degree of Doctor of Philosophy (Ph.D.) in the department of Law for the topic "Law Relating to Bail in India: A Human Rights Perspective" from Banaras Hindu University, Varanasi prior to joining the Judicial Service and was subsequently awarded the Ph.D. Degree on 24.11.2022.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus said qualification of Ph.D. Degree may be included in her service-records & prefixing word "Doctor" be added in the name of Smt. Shiva Pandey, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid letter dated 25.05.2023 (received online) of Smt. Shiva Pandey, Special Judge( E.C. Act), Pilibhit may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Pilibhit, for His Lordship's kind perusal and approval to the effect that copy of aforesaid letter dated 25.05.2023 (received online) along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Smt. Shiva Pandey, Special Judge (E.C. Act), Pilibhit, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
