May kindly see the online requisition dated 10.05.2023 of Smt Shuchi Srivastava, Additional Principal Judge, Family Court, Lucknow, requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 30912023. In support of her application, Smt Shuchi Srivastava furnished attested copies of LL.M. credentials comprising LL.M. Mark-sheets of both the years and copy of Degree for inclusion of her qualification in the service records. Along with her LL.M. credentials, she has also furnished the permission letter, issued by Admin A-4 section vide Court's letter no. 11477/IV-3060/Admin.(A-4) dated 22.08.2019, to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra, Haryana.

In this connection, it is submitted that Smt Shuchi Srivastava, joined the U.P. Judicial Service on 23.12.2003 as Additional Civil Judge (Junior Division), Jaunpur. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Smt Shuchi Srivastava completed two years LL.M. course (from distance learning mode) in the year May 2022, the final year (2nd year) marksheet was issued on 28.02.2023 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 28.04.2023 for the session May 2021, thus the said qualification may be included in her service-records.

In this context, it is submitted that an online query, dated 11.07.2023, was made by the office of Admin A-1 section asking Smt Shuchi Srivastava to furnish documents related to recognition of Kurukshetra University and approval of LL.M. course by University Grants Commission. In compliance of which, Smt Shuchi Srivastava furnished the documents relevant to recognition of Kurukshetra University and approval of LL.M. course by UGC (kindly see attachments dated 07.08.2023). In reply to the another query raised by Ld. Registrar(Judicial)(Budget) on 13.09.2023 & further by this office on 25.09.2023 regarding dates of issuance of marksheets of 1st year & 2nd year, she has furnished the clarification and supporting documents by attachment dated 15.09.2023 & 26.09.2023 mentioning that she reappeared in one paper L002 of LL.M. 1st year in session May 2022 and the marksheet was issued in Jan 2023, further the combined marksheet of 1st year & 2nd year issued on 28.02.2023.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Smt Shuchi Srivastava, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 10.05.2023 of Smt Shuchi Srivastava, Additional Principal Judge, Family Court, Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of her application along with copy of Mark-sheets (two years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Smt. Shuchi Srivastava, Additional Principal Judge, Family Court, Lucknow, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
