May kindly see the online application of Sri Shantanu Tyagi, Additional Chief Judicial Magistrate, Lucknow regarding grant of permission to publish a book written on ancient Indian achievements in the field of science and mathematics titled as "Sages of Bharat".

It is kindly requested to grant him the permission for the publication of the book. Moreover, it is submitted that G.O dated 11.10.1968 has been followed scrupulously by him. The book is being published by Rashtrodaya Prakashan. Thus, it is pertinent to mention here that this book will be published for writer having ISBN no in writer's details. Publisher will publish the book, will distribute the book to various book stalls, libraries and individuals, simultaneously will collect the sales realisation amount. The profit part will be shared with writer paying 30% of accumulated annual profit for writer's book after deducting applicable TDS every time. He has submitted details regarding publisher and royalty which is as follows for kind perusal:

It is further submitted that as the officer has already submitted that he will abide by the conditions of Govt. O.M. no. O-3134/II-B-1968 dated 11.12.1968 of rule 15 of U.P. Govt. Servant's Conduct Rules 1956, his case may be considered, but, acceptance of the request of the officer to write & get published the book is on discretion of the Court.

It is further to mention here that recently, vide order dated 23.04.2023 regarding reconstitution of different committees, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to publish book.

May therefore, if approved, the matter be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Senior Judge (J-1), for His Lordship's kind perusal and if His Lordship approves, Sri Shantanu Tyagi, Additional Chief Judicial Magistrate, Lucknow be granted permission to publish a book written on ancient Indian achievements in the field of science and mathematics titled as "Sages of Bharat" by Rashtrodaya Prakashan as requested, subject to the conditions of Govt. O.M. No. O-3143/ II-B-1968, dated 11.12.1968?
