In addition to the above, as evident from submitted attested copy of LL.M mark-sheets of two semesters and the copy of Degree Qualification, Sri Neeraj Singh, completed his one year LL.M. degree course in the year 2018 and was subsequently awarded the LL.M. Degree from Dr. Ram Manohar Lohia National Law University, Lucknow, on 25.07.2018, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Neeraj Singh, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 22.05.2023 of Sri Neeraj Singh, Civil Judge (Junior Division), Raebareli to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Samit Gopal, Administrative Judge, Raebareli, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Neeraj Singh, Civil Judge (Junior Division), Raebareli, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
