May kindly see the online requisition dated 06.06.2023 of Sri Dhirendra Kumar II, Judge, Special Court, C.B.I. Court no. 5, Lucknow whereby he has requested for inclusion of his LL.M. qualification in the service records. In support of the same, Sri Dhirendra Kumar II has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year and 2nd year & Degree Qualification, copy of letter of permission for pursuing the aforesaid course as well as documents related to recognition of Kurukshetra University, Kurukshetra, Haryana and approval of LL.M. degree course through open and distance learning mode, as supporting documents for inclusion of the aforesaid degree in his service record.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Sri Dhirendra Kumar II, aforesaid has completed his two-year LL.M. degree course in the year 2023 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 05.05.2023 thus, the said qualification may be included in his service records, as prayed for.

Several objections dated 16.6.2023 & 11.07.2023 were raised by this office regarding furnishing the attested copies of LL.M. credentials and the recognition of the university as well as approval of LL.M. course through distance learning mode & in reply, he has furnished the desired documents as well as clarification/ supporting documents by attachment dated 26.06.2023 & 09.08.2023, here on this portal.

In connection with the above, it is submitted that Sri Dhirendra Kumar II, aforesaid, joined the U.P. Judicial Service on 19.06.2006, initially as Additional Civil Judge(Junior Division), Lucknow. Further, it is relevant to mention here that Sri Dhirendra Kumar II, aforesaid, pursued his two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2020-2022, after joining the judicial service, with due permission of this Court, the letter of permission so obtained has been furnished by attachment dated 05.06.2023.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Dhirendra Kumar II, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the copy of aforesaid online requisition dated 06.06.2023 of Sri Dhirendra Kumar II, Judge, Special Court, C.B.I. Court no. 5 to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition dated 06.06.2023 along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Dhirendra Kumar II, Judge, Special Court, C.B.I. Court no. 5, Lucknow may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
