

## **Ld.Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 07.06.2023 of Sri Rohit Soni, the then Civil Judge(Junior Division), Gonda, presently posted as Nyayadhikari, Gram Nyayalaya, Tarabganj, Gonda requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 31652023. In support of his application, Sri Rohit Soni, furnished attested copies of LL.M. credentials comprising of LL.M. Mark-sheets of both the years and copy of Degree for inclusion of his qualification in the service records. Along with his LL.M. credentials, he has also furnished the copy of online approval letter, issued by this Court to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra as well as the documents related to the recognition of the University containing a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and its enclosures letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting papers for inclusion of the aforesaid degree in his service record.

In this connection, it is submitted that Sri Rohit Soni, joined the U.P. Judicial Service on 16.12.2019 as Civil Judge (Junior Division), Kannauj. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Sri Rohit Soni completed two years LL.M. course (from distance learning mode) in the year December 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the session May 2022, thus said qualification may be included in his service-records.

In this context, it is submitted that online query dated 16.06.2023, 08.08.2023 were made by the office of Admin A-1 section asking Sri Rohit Soni to furnish the attested copies of mark sheets and of LL.M. degree & in reply, he has furnished the desired documents by attachment dated 04.08.2023, 19.08.2023 Further, another query was made related to recognition of Kurukshetra University and approval of LL.M. course by University Grants Commission. In response to which, Sri Rohit Soni furnished the documents relevant to recognition of Kurukshetra University and approval of LL.M. course by UGC by attachments dated 28.08.2023.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Rohit Soni, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 07.06.2023 of Sri Rohit Soni, Nyayadhikari, Gram Nyayalaya, Tarabganj, Gonda may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gonda, for His Lordship's kind perusal and order to the effect that a copy of his online application along with copy of Mark-sheets (two years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Rohit Soni, Nyayadhikari, Gram Nyayalaya, Tarabganj, Gonda, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
