## Registrar (Judicial)(Budget)

May kindly see the online requisition dated 07.06.2023 of Smt Preetimala Chaturvedi, Chief Judicial Magistrate, Balrampur, requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 31742023. In support of her application, Smt Preetimala Chaturvedi furnished attested copies of LL.M. credentials comprising of LL.M. Mark-sheets of both the years and copy of Degree for inclusion of her qualification in the service records. Along with her LL.M. credentials, she has also furnished the permission letter, issued by Admin A-4 section vide Court's letter no. 1358/IV-4250 Admin. (A-4) dated 27.01.2020, to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra.

In this connection, it is submitted that Smt Preetimala Chaturvedi, joined the U.P. Judicial Service on 13.01.2017 as Judicial Magistrate, Gorakhpur. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Smt Preetimala Chaturvedi completed two years LL.M. course (from distance learning mode) in the year May 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the session May 2022, thus said qualification may be included in her service-records.

In this context, it is submitted that an online query, dated 11.07.2023, was made by the office of Admin A-1 section asking Smt Preetimala Chaturvedi to furnish documents related to recognition of Kurukshetra University and approval of LL.M. course by University Grants Commission. In compliance of which, Smt Preetimala Chaturvedi furnished the documents relevant to recognition of Kurukshetra University and approval of LL.M. course by UGC (kindly see attachments dated 26.07.2023).

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Smt Preetimala Chaturvedi, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 07.06.2023 of Smt Preetimala Chaturvedi, Chief Judicial Magistrate, Balrampur, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Subhash Vidyarthi, Administrative Judge, Balrampur, for His Lordship's kind perusal and order to the effect that a copy of her application along with copy of Mark-sheets (two years) and Degree of LL.M. (uploaded online on 26.07.2023) as well as attested copy of form of U.P. Nyayik Sewa of Smt Preetimala Chaturvedi, Chief Judicial Magistrate, Balrampur, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
