May kindly see the online requisition dated 07.06.2023 of Sri Anant Kumar, Additional Civil Judge(Junior Division), Ghazipur whereby he has requested for inclusion of his LL.M. qualification in the service records. In support of the same, Sri Anant Kumar, has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year and 2nd year & Degree Qualification, copy of letter of permission for pursuing the aforesaid course as well as documents related to recognition of Kurukshetra University, Kurukshetra, Haryana and approval of LL.M. degree course through open and distance learning mode, as supporting documents for inclusion of the aforesaid degree in his service record.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Sri Anant Kumar, aforesaid has completed his two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.03.2023 thus, the said qualification may be included in his service records, as prayed for.

Several objections dated 16.6.2023 & 11.07.2023 were raised by this office regarding furnishing the attested copies of LL.M. credentials and the recognition of Kurukshetra University, Kurukshetra, Haryana as well as approval of LL.M. course through distance learning mode & in reply, he has furnished the desired documents as well as clarification/ supporting documents by attachment dated 21.06.2023 & 08.08.2023, here on this portal.

In connection with the above, it is submitted that Sri Anant Kumar, aforesaid, joined the U.P. Judicial Service on 16.11.2019, initially as Civil Judge(Junior Division), Saharanpur. Further, it is relevant to mention here that Sri Anant Kumar, aforesaid, pursued his two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2019-2021, after joining the judicial service, with due permission of this Court in the middle of the course, the letter of permission so obtained has been furnished by attachment dated 08.08.2023.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Anant Kumar, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the copy of aforesaid online requisition dated 07.06.2023 of Sri Anant Kumar, Additional Civil Judge(Junior Division), Ghazipur to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Prakash Padia, Administrative Judge, Ghazipur, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Anant Kumar, Additional Civil Judge(Junior Division), Ghazipur, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
