May kindly see the online requisition dated 13.06.2023 of Sri Ravi Kumar, Civil Judge (Junior Division), Hapur requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 31902023. In view of the above, Sri Ravi Kumar, has furnished his duly attested scanned copies of LL.M. Marksheets of two semesters (consolidated as well as separately) and of the Degree Qualification, as supporting documents for the same.

In connection with the above, it is submitted that Sri Ravi Kumar, joined the U.P. Judicial Service on 11.07.2018, initially as Additional Civil Judge (Junior Division), Etah. Further, it is relevant to mention here that Sri Ravi Kumar, pursued his LL.M. one-year degree course from Indian Law Institute (Deemed University), Delhi, in the year 2017-2018, before joining the Judicial Service.

In addition to the above, as evident from submitted attested copy of LL.M mark-sheets of two semesters and the copy of Degree Qualification, Sri Ravi Kumar, completed his one year LL.M. degree course in the year 2018 and was subsequently awarded the LL.M. Degree from Indian Law Institute (Deemed University), Delhi, on 28.10.2022, thus, the said qualification may be included in his service records, as is prayed for.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Ravi Kumar, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 13.06.2023 of Sri Ravi Kumar, Civil Judge (Junior Division), Hapur to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Ashutosh Srivastava, Administrative Judge, Hapur, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets (consolidated as well as separately) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Ravi Kumar, Civil Judge (Junior Division), Hapur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
