May kindly see the online requisition dated 15.06.2023 of Sri Sandeep Gupta-I, Registrar, UP Information Commission, Lucknow, vide Case Id No.31982023, whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Sandeep Gupta-I has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year on 10.12.2022 and 2nd year dated 11.03.2023 & Degree Qualification along-with a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and its enclosures letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting papers for inclusion of the aforesaid degree in his service record.

In this connection, it is pertinent to mention here that Sri Sandeep Gupta-I in his application has submitted that he has pursued the above-mentioned LL.M. course after joining the service on being granted the permission of this Hon'ble Court to pursue the said course, the letter of permission so obtained has been provided by attachment dated 25.07.2023.

In this context, it is submitted that Sri Sandeep Gupta-I, aforesaid joined the U.P. Judicial Service on 15.06.2006 as Additional Civil Judge (Junior Division), Mirzapur. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., he completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Harayana on 31.03.2023, for the examination year 2022, thus the said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Sandeep Gupta-I, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 15.06.2023 of Sri Sandeep Gupta-I, Registrar, UP Information Commission, Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Sandeep Gupta-I, Registrar, UP Information Commission, Lucknow, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
