May kindly see the online requisition dated 20.01.2024 of Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot requesting for inclusion of his Ph.D. Degree in the service records & addition of prefixing the word "Dr." before his name vide Case Id. No. 32092023. In view of the above, Sri Surya Kant Dhar Dubey has furnished his duly scanned & attested copy of the Degree Qualification & copy of online permission letter of this Court for pursuing the aforesaid course, as supporting document for the same.

Several objections dated 21.02.2024 & 12.03.2024 were raised by this office and in reply, Sri Surya Kant Dhar Dubey, aforesaid has furnished the desired documents by attachment dated 28.02.2024 & 13.03.2024 respectively.

In this connection, it is submitted that Sri Surya Kant Dhar Dubey, aforesaid, joined U.P. Judicial Service on 28.05.2013 as Judicial Magistrate, Siddharth Nagar. Besides, as evident from his submitted attested copy of his degree of Ph.D., Sri Surya Kant Dhar Dubey, was awarded the degree of Doctor of Philosophy (Ph.D.) in the department of Law for the topic "Sentencing in Criminal Justice System in India: A Critical Study" from University of Delhi, and was subsequently awarded Ph.D. Degree on 24.02.2024. He has persued the aforesaid course after joining the Judicial Service with prior permission of this Court, copy of permission letter has been furnished hereon this portal by attachment dated 13.03.2024 at sl. no. 4.

Further, it is submitted that appointing authority of Judicial Officers is the Government of U.P., thus said qualification of Ph.D. Degree may be included in his service-records & prefixing word "Dr." be added before the name of Sri Surya Kant Dhar Dubey, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online application dated 20.01.2024 of Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Vikram D Chauhan, Administrative Judge, Chitrakoot for His Lordship's kind perusal and if His Lordship approves, a copy of aforesaid online application dated 20.01.2024 along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Judicial Service of Sri Surya Kant Dhar Dubey, Chief Judicial Magistrate, Chitrakoot may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary formal orders of the Government of U.P. in instant matter related to inclusion of Ph.D. Degree in Service record and addition of prefixing word "Dr." before his name?
