May kindly see the online application of Sri Pankaj Kumar Singh, District & Sessions Judge, Bulandshahar regarding grant of permission to use staff car for undertaking journey from Bulandshahar to Udaipur Rajasthan on 10.06.2023 morning during his recess program from 11-06-2023 to 20-06-2023 and will return Bulandshahar on 20-06-2023 in the night.

In his application, Sri Pankaj Kumar Singh has stated that he wants to go to Udaipur Rajasthat on 10.06.2023 morning during his recess program from 11-06-2023 to 20-06-2023 and will return Bulandshahar on 20-06-2023 in the night. He wants to use official car bearing registration no. UP 13 AG 0496 for the said journey. He will pay the charges as per rules. He has, therefore, requested to place his application before the Hon'ble Court for grant of permission to use official vehicle for the aforesaid journey. It has been further asked from the officer that whether he has performed the journey in anticipation of permission of Hon'ble High Court and if yes to intimate the complete details about journey i.e. total distance travelled, challan receipts and if the journey exceeds from 200 kms, then to intimate about the amount paid. As intimated later by him, it is submitted that he has accomplished his journey from Bulandshahar to Udaipur Rajasthan in official car, travelled 2297 kms. & has paid Rs. 6891/through Challan Receipt No. FJ00081 which has been deposited in SBI, Bulandshahar (Copy of Challan can be seen as attachment). He has, therefore, requested that Hon'ble Court may kindly be moved to accord him permission for use of the official vehicle for the above mentioned visit.

In this connection, it is submitted that the date for his visit from Bulandshahar to Udaipur Rajasthan is passed over & in the meantime the journey has already been performed by the officer as records shows. He has used the official vehicle for his personal journey from Bulandshahar to Udaipur Rajasthan which is in accordance with Rules & the G.O. and has deposited due money, his request to use official vehicle appears to be considerable.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar Judgeship for His Lordship's kind perusal & orders regarding grant of ex-post facto permission now to use official vehicle by Sri Pankaj Kumar Singh, District & Sessions Judge, Bulandshahar for the journey mentioned above, as per the provisions of relevant Rules and G.O.?
