May kindly see the online application of Sri Anubhava Dwivedi, Additional District & Sessions Judge, Varanasi who joined service on 08.05.2009, drawing gross salary of Rs. 2,05,941/- & take home salary of Rs. 1,52,155/- regarding information about purchase of a new Maruti Suzuki Wagon R Car, allotted reg. no. UP70 GL9314 (Copy of RC can be seen as attachment namely- Papers relating to newly purchased car, page no. 4) intimated through application dated 10.07.2023.

Through his application, Sri Anubhava Dwivedi has submitted information about purchase of a new car on 06.03.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Bright 4 Wheels Sales Prayagraj Pvt. Ltd., LLP, Prayagraj, for Rs. 6,52,500/- in total (Copy of invoice can be seen as attachment namely- Papers relating to newly purchased car, page no. 3), source of money of which is that Rs. 6,17,500/- (Rs. 50,000/- on 05.03.2023 Rs. 4,00,000 on 06.03.2023/- Rs. 1,67,500/- on 10.03.2023) is stated to have been paid out of his saving bank account (copy of statement of A/c can be seen as attachment namely- Bank Statement), Rs. 20,000/- is stated to have been paid in exchange of his old car (copy of RC of his old car and purchase receipt can be seen as attachments namely- Copy of RC of old car and Old car price receipt), Rs. 15,000/- is stated to have been given as exchange bonus under the then prevalent scheme by Maruti Suzuki. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Varanasi for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
