May kindly see the online requisition dated 10.07.2023 (received online) alongwith application dated 20.06.2023 submitted by attachment dated 10.07.2023 of Sri Vikas Srivastava-I, Additional District & Sessions Judge, Prayagraj requesting for addition of the prefixing word "Doctor" vide Case Id. No. 32642023. In view of the above, Sri Vikas Srivastava-I, has furnished his duly attested scanned copies of the Degree Qualification, as supporting document for the same.

In this connection, it is submitted that Sri Vikas Srivastava-I, aforesaid, joined U.P. Judicial Service on 26.03.2021 as Additional District & Sessions Judge, Prayagraj. Besides, as evident from his submitted attested copy of his degree of Ph.D., Sri Vikas Srivastava-I, was awarded the degree of Doctor of Philosophy (Ph.D.) in the department of Law for the topic "Invalidity and Termination of Treaties Under International Law" in the year 2011 from Banaras Hindu University, Varanasi and was subsequently awarded the Ph.D. Degree on 24.02.2013, prior to joining the judicial service & the said Ph. D. degree has already been included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus the prefixing word "Doctor" be added in the name of Sri Vikas Srivastava-I, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid requisition dated 10.07.2023 (received online) of Sri Vikas Srivastava-I, Additional District & Sessions Judge, Prayagraj, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad/Prayagraj, for Her Lordship's kind perusal and approval to the effect that copy of aforesaid requisition dated 10.07.2023 (received online) along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Sri Vikas Srivastava-I, Additional District & Sessions Judge, Prayagraj may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
