May kindly see the online requisition dated 24.07.2023 of Sri Krishna Kumar -VI, the then Special Judge(U.P. Dacoity A.A.), Farrukhabad, presently posted as Additional Principal Judge, Family Court, Barabanki vide case id no. 32812023 whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Krishna Kumar -VI has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year dated 09.02.2022, 2nd year dated 15.06.2023 & of Degree Qualification dated 15.09.2023 as well as copy of online permission letter for pursuing the aforesaid course. In addition, a copy of letter no. F.No. 74-2/2018 (DEB-I) Nov, 2019 of the Secretary, Distance Education Bureau, University Grants Commission regarding recognition of Kurukshetra University, Kurukshetra, Haryana by attachment at annexure 4 and other related documents by attachment dated 24.07.2023 as annexure 5 & 6, as supporting papers for inclusion of the aforesaid degree in his service record.

In this context, an objection dated 27.07.2023 was raised for submitting the necessary papers and in reply there to, he has submitted the required papers by attachment dated 01.12.2023.

In this context, it is submitted that Sri Krishna Kumar -VI, aforesaid joined the U.P. Judicial Service on 08.02.2007 as Judicial Magistrate, Maharajganj. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 15.09.2023 for the examination year 2022. It is pertinent to mention here that Sri Krishna Kumar -VI in his application has submitted that he pursued the above-mentioned LL.M. course after joining the service on being granted the permission of this Hon'ble Court to pursue the said course (copy of online permission letter has been furnished by attachment dated 24.07.2023 at annexure-1), thus said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Krishna Kumar -VI, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 24.07.2023 of Sri Krishna Kumar -VI, Sri Krishna Kumar -VI, the then Special Judge(U.P. Dacoity A.A.), Farrukhabad, presently posted as Additional Principal Judge, Family Court, Barabanki, may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Barabanki, for His Lordship's kind perusal and order to the effect that a copy of his online requisition dated 24.07.2023 along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Krishna Kumar -VI, Sri Krishna Kumar -VI, the then Special Judge(U.P. Dacoity A.A.), Farrukhabad, presently posted as Additional Principal Judge, Family Court, Barabanki, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government

of U.P. in instant matter relating to inclusion of LL.M. Degree in service records?
