May kindly see the online application of Sushri Ayushi Chaturvedi, Civil Judge (Junior Division), Hamirpur by which she has submitted supplementary details/ papers in connection with information about gifting of Hyundai santro car to her real brother Sri Atiksh Chaturvedi in compliance of Court's order.

In this connection, it is submitted that the officer has made a gift of her Hyundai Santro car bearing number UP32EF7008 to her real brother Mr. Atiksh Chaturvedi on 11-04-2023 for his occupational needs out of natural love and affection. She had received the said car on 03-08-2019 from her mother Mrs. Kiran Chaturvedi as gift. The matter was submitted before Hon'ble Mr. Justice Syed Aftab Husain Rizvi, nominated as Administrative Judge, Hamirpur for disposal of the matters. Thus, His Lordship had been pleased to order:

"Old RC is in the name of the Officer and date of registration is 06.06.2012. The submission of the Officer is that the vehicle was gifted to her by her mother on 03.08.2019. No document of this gift has been attached. Officer to attach the gift deed executed by her mother in her favour and also explain the source of income of her mother from which the vehicle was purchased."

The order was communicated online to the officer.

In reply of the Court's order, Sushri Ayushi Chaturvedi has sent her reply & again a supplementary note dated 03.11.2023 has been put up before the Hon'ble Court upon which His Lordship has been pleased to order:-

"The Officer has submitted that gift deed in her favour has been lost. The Officer to produce any document showing the vehicle was originally purchased by her mother and also informed the date of purchase."

The order was communicated online to the officer.

In reply of the Court's order, Sushri Ayushi Chaturvedi has stated that the aforementioned Hyundai Santro car was purchased by her mother Mrs. Kiran Chaturvedi on 06-06-2012 and was gifted to the officer on 03-08-2019 by a gift deed. The applicant was asked to put forth any document showing that the aforesaid Hyundai Santro car was first purchased by her mother and also inform the date of purchase. In the light of above objection, the officer is filing a detailed document of Vehicle History Report of Registration number UP32EF7008 received from Regional Transport Office Lucknow on 29-02-2024 (copy of the same can be seen as attachment). On Page number 2 of the submitted document, it clearly states that the first owner of the aforesaid car was Mrs. Kiran Chaturvedi from 06-06-2012 to 03-08-2019. Thereafter, the owner of the aforesaid Hyundai Santro car was the officer that is Ayushi Chaturvedi.

Under the facts & circumstances, may, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Vikas Budhwar, Administrative Judge, Hamirpur, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Hamirpur for His Lordship's kind perusal & further order in the matter of information about gifting of Hyundai santro car by Sushri Ayushi Chaturvedi, Civil Judge (Junior Division), Hamirpur to her real brother Sri Atiksh Chaturvedi?
