May kindly see the online requisition dated 21.07.2023 of Sri Nishchal Shukla, Deputy Secretary, U.P. State Legal Services Authority, Lucknow, vide Case Id No.33032023, whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Nishchal Shukla has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year issued on 10.12.2022 and 2nd year dated 10.12.2022 & Degree along-with a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and its enclosures letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting papers for inclusion of the aforesaid degree in his service record.

In this connection, it is pertinent to mention here that Sri Nishchal Shukla in his application has submitted that he pursued the above-mentioned LL.M. course after joining the service on being granted the permission of this Hon'ble Court to pursue the said course vide Hon'ble Court's Letter No. 3375/IV-4244/Admin. (A-4) dated 29.02.2020 (attached as letter dated 21.07.2023 uploaded in attachement). He has also submitted that the respective marksheet of 1st year was issued on 10.12.2022 with final year marksheet, as he reappeared in 02(two) subjects of 1st Year LL.M. examination to improve his marks in those subjects.

In this context, it is submitted that Sri Nishchal Shukla, aforesaid joined the U.P. Judicial Service on 27.01.2017 as Additional Civil Judge (Junior Division), Barabanki. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023, for the examination year 2022, thus said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Nishchal Shukla, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 21.07.2023 of Sri Nishchal Shukla, Deputy Secretary, U.P. State Legal Services Authority, Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Nishchal Shukla, Deputy Secretary, U.P. State Legal Services Authority, Lucknow, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
