May kindly see the online requisition vide Case Id No. 33042023 dated 26.07.2023 of Sri Abhishek Srivastava, Registrar (Judicial)(Infrastructure-HC), High Court, Allahabad requesting for inclusion of LL.M. qualification in his service records.

In his application, Sri Abhishek Srivastava, wants to apprise that vide Court's Letter No. 7311/IV-3287/Admin.(A-4) Dated: 25/06/2021, he has been granted permission to take admission and pursue LL.M. Course through Kurukshetra University, Haryana. He has successfully pursued LL.M. distance learning course/programme in May, 2022 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. By attaching relevant documents, he has requested to add his LL.M. Degree in his Service Record.

He has also furnished all of his LL.M. credentials comprising LL.M. Mark-sheets of both years and copy of Degree. Along with his LL.M. credentials, he has also furnished Court's permission letter no. 7311/IV-3287/ Admin (A-4) dated 25.06.2021, to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra, and documents relating to recognition of Kurukshetra University and the LL.M. course (All as attachments).

In this connection, it is submitted that Sri Abhishek Srivastava joined the U.P. Judicial Service on 15.06.2006. Besides, as evident from submitted attested copies of Mark-sheets (Two-years) and Degree of LL.M., Sri Abhishek Srivastava completed two years LL.M. course (from distance learning mode) in May 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 30.06.2023 for the session May 2022, thus said qualification may be included in his service records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Abhishek Srivastava, aforesaid, by an order of the Government of U.P. on the recommendation of his parent department. Therefore, it seems proper that the aforesaid online requisition dated 26.07.2023 of Sri Abhishek Srivastava, Registrar (Judicial)(Infrastructure-HC), High Court, Allahabad may be sent to the Government of U.P. for obtaining necessary orders.

It is also noteworthy here that as the officer is presently posted in this Hon'ble Court, his instant matter is likely to be placed before Hon'ble The Chief Justice.

May, therefore, if approved, the matter may kindly be placed before Hon'ble the Chief Justice, for His Lordship's kind perusal and if approved by his Lordship, for order to the effect that a copy of application along with copy of Mark-sheets (two years) and Degree of LL.M. (uploaded online on 26.07.2023) as well as attested copy of form of U.P. Nyayik Sewa of Sri Abhishek Srivastava, Registrar (Judicial)(Infrastructure-HC), High Court, Allahabad, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
