May kindly see the online application of Sri Mohd. Shahnawaz Ahmad Siddiqui, Judicial Magistrate, Bhadohi at Gyanpur who joined service on 15.11.2019, drawing gross salary of Rs. 1,05,529/- & take home salary of Rs. 82,388/- regarding information about purchase of a new Maruti Suzuki Ciaz car, allotted reg. no. UP70 GR2011 (copy of RC can be seen as attachment namely- Original RC of car), intimated through application dated 17.08.2023.

Through his application, Sri Mohd. Shahnawaz Ahmad Siddiqui, has submitted information about purchase of a new car on 31.07.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from KTL NEXA Cyber heights, Vibhuti khand, Gomti nagar, Lucknow, for Rs. 12,08,000/- (copy of invoice can be seen as attachment namely- TAX INVOICE/TEMPORARY RC/INSURANCE Attached), source of money of which is that Rs. 10,50,000/- has been taken as loan from S.B.I, repayable in 84 monthly EMIs of Rs. 17,000/- (copy of 'loan arrangement letter' can be seen as attachment namely- Statement of loan and loan sanction paper), Rs. 1,50,000/- has been taken as personal loan S.B.I, repayable in 72 monthly EMIs of Rs. 3,000/- (copy of 'personal loan arrangement letter' can be seen as attachment namely- Personal loan arrangement letter), Rs. 8,000 is stated to have been paid in cash (copy of receipt can be seen as attachment namely- Copy of Advance payment attached herewith). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Sameer Jain, Administrative Judge, Bhadohi at Gyanpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Bhadohi at Gyanpur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
