

## **Registrar (J)(Budget)**

May kindly see the online requisition dated 28.07.2023 of Smt. Shipra Singh-II, Additional Civil Judge (Junior Division), Mathura, whereby she has requested for inclusion of her LL.M. qualification in her service records. In support of the same, Smt. Shipra Singh-II has furnished her LL.M. credentials comprising attested copies of Marksheets of 1st year dated 09.02.2022 and 2nd year dated 24.12.2022 and Degree Qualification dated 28.04.2023 as well as copy of the online permission letter for pursuing the aforesaid course alongwith a letter no. F.No. 74--2/2018 (DEB-I) dated 18.10.2018 and November 2019 of Secretary, UGC, as supporting documents for inclusion of the aforesaid degree in her service records.

In this connection, it is pertinent to mention here that Smt. Shipra Singh-II in her application has submitted that she pursued the aforesaid LL.M. course before joining the judicial services and later on granted permission by this Hon'ble Court after considering his request in this regard, the copy of online permission letter has been attached hereon by attachment dated 23.08.2024, under the heading 'Permission Letter'.

In this regard, several objections dated 17.08.2023, 09.10.2023, 16.11.2023, 03.09.2024 and 06.09.2024 were raised by this office for furnishing copy of documents related recognition of Kurukshetra Univeristy, Kurukshetra, Haryana and approval of the aforesaid course and permission of letter by this Hon'ble Court to persue the aforesaid course as well as officer is also requested to clarify the fact that the month & year of 1st year and 2nd year exams are same i.e. May 2021. In reply thereto, she has furnished desired documents by attachment dated 24.08.2023, 23.08.2024, 04.09.2024 and 06.09.2024. Furthermore, in response of query dated 03.09.2024, she has replied the following on 04.09.2024, in verbatim:

**" It is clarify that Distance Learning course of LL.M. from Kurukshetra University is approved by the UGC for relevant year (2019)."**

In this context, it is further submitted that Smt. Shipra Singh-II, aforesaid joined the U.P. Judicial Services on 16.12.2019 as Additional Civil Judge (Junior Division), Mau. Besides, as evident from submitted attested copies of Marksheets of both the years and the Degree qualification of LL.M., she has completed LL.M. course and was subsequently awarded degree from Kurukshetra Univeristy, Kurukshetra on 28.04.2023 for the examination year 2021, thus the said qualification may be included in her service records.

It is further submitted that the appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. degree may be included in the service records of Smt. Shipra Singh-II, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems appropriate that the aforesaid online requisition/application dated 28.07.2023 of Smt. Shipra Singh-II, Additional Civil Judge (Junior Division), Mathura may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Mathura for His Lordship's kind perusal and order to the effect that a copy of online requisition/application dated 28.07.2023 alongwith the copy of Marksheets (both years) and Degree of LL.M., as well as attested copy of form of U.P. Nyayik Sewa of Smt. Shipra Singh-II, Additional Civil Judge (Junior Division), Mathura may be sent to the Joint Secretary, Appointment Section- 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P., in the instant matter?
