May kindly see the online requisition dated 05.08.2023 of Sri Aashish Pandey, Additional Civil Judge(Senior Division)/ACJM, Etawah whereby he has requested for inclusion of his LL.M. qualification in the service records. In support of the same, Sri Aashish Pandey has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year and 2nd year & Degree Qualification, copy of letter of permission for pursuing the aforesaid course as well as documents related to recognition of Kurukshetra University, Kurukshetra, Haryana and approval of LL.M. degree course through open and distance learning mode, as supporting documents for inclusion of the aforesaid degree in his service record.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Sri Aashish Pandey, aforesaid has completed his two-year LL.M. degree course in the year 2023 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.03.2023 thus, the said qualification may be included in his service records, as prayed for.

An objections dated 09.08.2023 was raised by this office regarding furnishing the attested copies of LL.M. credentials & in reply, the desired documents has been furnished by attachment dated 10.08.2023, here on this portal.

In connection with the above, it is submitted that Sri Aashish Pandey, aforesaid, joined the U.P. Judicial Service on 12.01.2017, initially as Additional Civil Judge(Junior Division), Balrampur. Further, it is relevant to mention here that Sri Aashish Pandey, aforesaid, pursued his two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2020-2022, after joining the judicial service, with due permission of this Court, the letter of permission so obtained has been furnished by attachment dated 31.07.2023.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Aashish Pandey, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the copy of aforesaid online requisition dated 05.08.2023 of Sri Aashish Pandey, Additional Civil Judge(Senior Division)/ACJM, Etawah to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Etawah, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Aashish Pandey, Additional Civil Judge(Senior Division)/ACJM, Etawah may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
