

**Id. Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 07.08.2023 of Sri Shahzad Ali, Additional District Judge (FTC), Bulandshahar whereby he has requested for inclusion of his M.B.A. qualification in his service records. In support of the same, Sri Shahzad Ali has furnished his M.B.A. credentials comprising attested copies of Mark-sheets as well as of the degree qualification of Maharshi Dayanand University, Rohtak, Haryana as supporting papers for inclusion of the aforesaid degree in his service record.

In this context, it is submitted that Sri Shahzad Ali, aforesaid joined the U.P. Judicial Service on 23.01.2023 as Additional District Judge (FTC), Bulandshahar. Besides, as evident from submitted attested copies of Mark-sheets of four semesters and the Degree qualification of M.B.A., he has completed two years M.B.A. course in 2009 and was subsequently awarded Degree from Maharshi Dayanand University, Rohtak, Haryana on 31.03.2011, for the examination held in the year 2009. Sri Shahzad Ali, in his application has submitted that he has pursued the above-mentioned M.B.A course before joining the U.P. Judicial Service.

Further, in reply to the objection raised by this section regarding the ambiguity in the date of issuance of 1st and 2nd semester marksheets, not mentioning of the degree in the form of U.P. Judicial Service/UPHJS, he has submitted that there was compartment in 1st semester and the compartment was cleared later on so the Marksheet was issued in 2009 year after clearing the compartment. at the time of submitting form of UPHJS he did not receive the Original Degree from the University because he never needed it but when he qualified for the interview of UPHJS he submitted the Mark sheets of all semesters excluding degree at the time of interview but after the result of interview he visited the University for taking the degree after & receiving the same he submitted the same before the Hon'ble High Court through this portal, the aforesaid clarification has been furnished submission dated 01.09.2023, thus the said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of M.B.A. Degree may be included in the service records of Sri Shahzad Ali, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 07.08.2023 of Sri Shahzad Ali, Additional District Judge (FTC), Bulandshahar, may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (four semesters) and Degree of M.B.A. qualification as well as attested copy of form of U.P. Nyayik Sewa of Sri Shahzad Ali, Additional District Judge (FTC), Bulandshahar, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
