

## **Registrar (J)(Budget)**

May kindly see the online application/ request no. S00033542023 dated 04.02.2024 of Sri Rishabh Chaturvedi, Judicial Magistrate, Jaunpur whereby he has requested for inclusion of his LL.M. qualification in his service records.

Sri Rishabh Chaturvedi, in his application, has submitted that he has been granted prior permission from this Hon'ble Court to pursue the aforesaid LL.M. Course from Kurukshetra University, Haryana and he successfully pursued LL.M. distance learning course/program in the year 2022 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record.

An objection dated 06.02.2024 was raised by this office for furnishing the required documents & in reply, he has submitted the copy of desired documents by attachment dated 12.02.2024.

In support of the same, Sri Rishabh Chaturvedi has furnished copies of recognition-related papers of the University (from attachment Sl no. 5-9), copy of permission letter of this Court regarding grant of earlier permission( at attachment Sl. no. 1) and his LL.M. credentials comprising attested copies of Mark-sheets of both the years (at attachment nos. 10-11) and degree by attachment dated 12.02.2024 (at attachment Sl. no. 12).

In this context, it is submitted that Sri Rishabh Chaturvedi, aforesaid joined the U.P. Judicial Service on 17.12.2019 as Additional Civil Judge(Junior Division), Kannauj. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the examination year May 2022 for LL.M. Pre date of result 09.02.2022 & LL.M. II final year's date of result 10.12.2022 as endorsed on marksheets.

Further, it is submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Rishabh Chaturvedi, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/ request dated 04.02.2024 of Sri Rishabh Chaturvedi, Judicial Magistrate, Jaunpur may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Jaunpur for His Lordship's kind perusal and if His Lordship approves, a copy of online application/ request dated 04.02.2024 of Sri Rishabh Chaturvedi, Judicial Magistrate, Jaunpur along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
