May kindly see the online application of Sri Vikas Nagar, Additional District & Sessions Judge (POCSO), Gautambuddha Nagar who joined service on 19.06.2006, drawing gross salary of Rs. 2,64,956/- & take home salary of Rs. 1,88,500/- regarding information about purchase of a new Maruti Suzuki Grand Vitara car, allotted reg. no. UP16 DV2372 (Copy of RC can be seen as attachment namely- RC), intimated through application dated 08.08.2023.

Through his application, Sri Vikas Nagar has submitted information about purchase of a new car on 03.07.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Basera Velocity Cars, Basera Hotels and Resorts LLP 906, Seva Ram Oil Mills, Elite Sipri Road, Civil Lines, Jhansi for Rs. 15,44,551/- in total (Copy of Tax invoice can be seen as attachment namely- Invoice), source of money of which is that Rs. 15,34,307/- (Rs. 9,00,000/- Rs. 6,34,307/-) is stated to have been paid out of his saving account (copy of statement of his A/c can be seen as attachment namely- Vikas Bank Statement past 6 months), Rs. 10,244/- is stated to have been paid in cash. The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is pertinent to mention here that the officer has received an amount of Rs. 13,50,000/- (Rs. 5,00,000/- Rs. 5,00,000/- Rs. 3,50,000/-) from his wife (Smt. Pratiksha Nagar, Additional District & Sessions Judge, Gautambuddha Nagar) (copy of statement of his wife's account as well as FDRs can be seen as attachments namely- Copy of statement of Fixed Deposit and Pratiksha Nagar's Bank statement past 6 months)

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Rajiv Gupta, Administrative Judge, Gautambuddha Nagar also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Gautambuddha Nagar for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
