May kindly see the online application of Sri Ashish Jain, Principal Judge, Family Court, Mathura by which he has submitted supplementary details/ papers in connection with grant of permission to use staff car for undertaking journey from Mathura to Meerut on 09.08.2023 for some urgent work in compliance of Court's order.

In this connection, it is submitted that the officer through his earlier application he has requested for grant of permission to use staff car bearing registration no. UP 70 AG 2010 from Mathura to Meerut on 09.08.2023. The distance travelled by him for the same journey was 464 kms. & has paid Rs. 792/- through Challan Receipt No. HH00017 on 16.08.2023 which has been deposited in SBI, Mathura. The matter was submitted before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura for disposal of the matters, upon consideration of the matter, His Lordship had been pleased to order:

"There is another request for permission to travel by official car from Mathura to Meerut for 31.05.2023. In the said request of travel from Mathura to Meerut, 255 Km. has been shown over and above 200 Km. and for the said distance an amount of Rs. 465/- has been deposited through challan on 15.06.2023. But in the present matter of travel from Mathura to Meerut, total distance travelled is 464 Km., out of which 264 Km. is additional over and above 200 Km. and for the said distance an amount of Rs. 792/- has been deposited through challan on 16.08.2023. Therefore it is to be clarified by the Officer as well as Office within two weeks, as to how there is so much difference in amount paid for 264 Km. and 255 Km."

The order was communicated online to the officer.

In reply/compliance of the Court's order, the officer has submitted reply on 18.11.2023 & a supplementary note dated 25.11.2023 was put up before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Mathura, upon which His Lordship has been pleased to order:-

"I have passed a detailed order in Application No S0003146/2023 of the same officer Sri Ashish Jain, Principal Judge, Family Court, Mathura through raise objection today i.e. on 01.02.2024 and under the same the officer shall deposit the total amount of the total distance travelled by him in this application also on 09.08.2023 out of his work area/jurisdiction i.e. for going from Mathura to Meerut, at the rate of Rs.3/- per km. within two weeks and then submit for permission."

The order was communicated online to the officer.

In reply of the Court's order, the officer has stated that-

मेरे द्वारा दिनांक 09.08.2023 को मथुरा से मेरठ आने जाने के लिए कुल 464किमी. की दूरी की निजी यात्रा की गयी थी। उक्त 464 किमी. की निजी यात्रा करने का किराया मुव. 03 रुपये प्रति किमी.की दर से कुल 1392 /- रुपये बनते हैं।

भारतीय स्टेट बैंक में दिनांक 17.08.2023 को मुव. 792/- रुपये चालान संख्या HH00017 जमा कर दिये गये हैं। शेष धनराशि 1392-792=600/- रुपये दिनांक 08.02.2024 को भारतीय स्टेट बैंक के चालान संख्या B801958 से जमा कर दिये गये हैं। बैंक चालान संलग्न है।

In this connection, it is submitted that the officer has travelled on 09.08.2023 from Mathura to Meerut a distance of 464 kms. for his personal journey by his private car bearing reg. no. UP 70 AG 2010. In this way, the journey from Mathura to Meerut @ 3 Rs. per kms. of used fuel is Rs. 1392/-. It is pertinent to mention here that Rs. 792/- has been deposited in SBI on 17.08.2023 through challan no. HH00017. Therefore, 1392-792= Rs. 600/- is stated to have been paid through challan no. B801958 in SBI, Mathura on 08.02.2024. Copy of Bank Challan can be seen as attachment.

An offline note has also been put up before Hon'ble The Chief Justice in the matter for inviting government's attention to the old G.O.s, old limit of private use of govt. vehicle per month and old rate of extra charges beyond private use of 200 kms. per month for reconsideration, amendment and for issuing revised G.O. taking into consideration the price of petrol/diesel at present.

Under the facts & circumstances, may, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge Mathura Judgeship for His Lordship's kind perusal & if His Lordship approves, Sri Ashish Jain, Principal Judge, Family Court, Mathura be granted ex-post permission now to use official vehicle for the journey from Mathura to Meerut on 09.08.2023 for some urgent work.
