May kindly see the online requisition dated 10.08.2023 of Sri Dharmendra Kumar Pandey, Presiding Officer, Motor Accident Claims Tribunal, Firozabad vide case no. 33622023 whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Dharmendra Kumar Pandey has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year dated 09.02.2022 , 2nd year dated 11.03.2023 & Degree Qualification dated 31.03.2023, copy of the letter of permission for pursuing the aforesaid Course as well as a letter dated 18.12.2023 of the Director (CDOE), Kurukshetra University, Kurukshetra along-with copy of letter no. F.No.74-2/2018(DEB-I) Dated: 18.10.2018 of the Secretary, UGC regarding recognition of the Kurukshetra University & approval of LL.M. Course under the heading "Letter" by attachment dated 09.01.2024, as supporting documents for inclusion of the aforesaid degree in his service record.

In this context, several objections dated 28.08.2023, 13.10.2023 & 02.11.2023 were raised by this office regarding submission of attested copies of LL.M. credentials and papers regarding recognition of Kurukshetra University by UGC & approval of the aforesaid course & in reply thereto, he has submitted the required papers by reply dated 05.09.2023, 17.10.2023 & 09.01.2024.

[Besides, it is pertinent to mention here that Sri Dharmendra Kumar Pandey in his application has submitted that he has pursued the above-mentioned LL.M. course after joining the Higher Judicial service on being granted the permission of this Hon'ble Court to pursue the said course which was communicated through letter no. 8703/IV-4040/ Admin A-4 dated 06.10.2020, the letter of permission granted from this Court has been furnished by attachment dated 10.08.2023 under the heading "Permission".

In this context, it is submitted that Sri Dharmendra Kumar Pandey, aforesaid joined the U.P. Higher Judicial Service on 19.08.2013 as Additional District & Sessions Judge, Mau. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., he has completed two years LL.M. course in March 2023 for the session 2020-2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Harayana on 31.03.2023, for the examination year May 2022, thus the said qualification may be included in his service-records.

Further, it is submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Dharmendra Kumar Pandey, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 10.08.2023 of Sri Dharmendra Kumar Pandey, Presiding Officer, Motor Accident Claims Tribunal, Firozabad, may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rohit Ranjan Agarwal, Administrative Judge Firozabad Judgeship, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of

LL.M. as well as attested copy of form of U.P. Higher Judicial Service of Sri Dharmendra Kumar Pandey, Presiding Officer, Motor Accident Claims Tribunal, Firozabad, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
