May kindly see the online requisition dated 10.08.2023 of Smt. Anshika Lal, Registrar, Land Acquisition, Rehabilitation & Resettlement Authority, Moradabad requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 33632023. In view of the above, Smt. Anshika Lal, aforesaid, has furnished her duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification as well as documents related to the University and letter of permission for pursuing LL.M. Degree course, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Smt. Anshika Lal, aforesaid has completed her two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.03.2023 thus, the said qualification may be included in her service records, as prayed for.

An objection dated 10.08.2023 was raised by this office regarding furnishing the attested copies of LL.M. credentials and the recognition of the university as well as approval of LL.M. course through open & distance learning mode & in reply, she has furnished the desired documents as well as clarification/ supporting documents by attachment dated 08.09.2023 here on this portal.

In connection with the above, it is submitted that Smt. Anshika Lal, aforesaid, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Azamgarh. Further, it is relevant to mention here that Smt. Anshika Lal, aforesaid, pursued her two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2020-2022, after joining the judicial service with prior approval of this court, the letter of permission so obtained has been furnished by attachment dated 08.09.2023.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Smt. Anshika Lal, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 10.08.2023 of Smt. Anshika Lal, Registrar, Land Acquisition Rehabilitation & Resettlement Authority, Moradabad to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajeev Misra, Administrative Judge, Moradabad for His Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Smt. Anshika Lal, Registrar, Land Acquisition Rehabilitation & Resettlement Authority, Moradabad may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
