May kindly see instant online case id no. S00033662023 dated 10.08.2023 of Ms. Anchal Rana, the then Civil Judge (Junior Division), Etah, presently posted as Additional Civil Judge (Senior Division), Etah, regarding addition of surname, i.e. 'Dhawan' to her name, thereby changing her name to 'Anchal Rana Dhawan' in her service records on account of her marriage to Mr. Akshay Dhawan. She has also submitted the supporting papers, i.e. **Marriage Certificate & Gazette notification in this regard** as attachments dated 10.08.2023, hereon this portal which were subsequently forwarded on 11.08.2023 by the District Judge, Etah.

Further, in terms of provisions contained in G.O. No. 3497/III-500(5)-46 dated 06-11-1946, vide this office response dated 22.08.2023, she was asked to submit to publish notice of such intention in a state newspaper as well as some newspaper in the locality where she ordinarily resides and to send the original copies of such newspapers alongwith original affidavit containing the relevant facts and her application to change her name (all in hardcopies) preferably by registered post, to this Hon'ble Court at the earliest, while also uploading the same hereon this portal,

Going further, vide her response dated 01.05.2024, she has submitted all the required papers including the affidavit containing the relevant facts and the advertisements published in this regard as attachments dated 01.05.2024 under headings, '**Affidavit**', '**Indian Express page 19**' & '**Jansatta page 2**' and informed that she has sent the hard copies of all the documents / attachments in original alongwith the application to this Court through the District Court.

It is further submitted that appointing authority of Judicial Officers of Uttar Pradesh Nyayik Sewa is the Government of Uttar Pradesh. Therefore it seems proper that aforesaid application of Ms. Anchal Rana, Additional Civil Judge (Senior Division), Etah, regarding addition of surname, i.e. 'Dhawan' to her name, thereby changing her name to 'Anchal Rana Dhawan' in her service records on account of her marriage, may be sent to the Government of U.P. for obtaining orders in this matter, in accordance with G.O. No. 3497/III-500(5)-46 dated 06-11-1946.

In the facts and circumstances as mentioned above, if approved by Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Etah, aforesaid application of Ms. Anchal Rana, Additional Civil Judge (Senior Division), Etah, regarding addition of surname, i.e. 'Dhawan' to her name, thereby changing her name to 'Anchal Rana Dhawan' in her service records on account of her marriage to Mr. Akshay Dhawan, alongwith all the supporting papers submitted to this Hon'ble Court in this regard, including the original copies of Newspapers, containing the advertisements, original affidavit, attested photocopy of her application form of Uttar Pradesh Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow, for obtaining necessary orders of the Government in this matter?
