In this connection, it is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956: -

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

It is further to submit that as the officer has purchased the property from Government Organisation/ a regular & reputed dealer, he has submitted the required information on purchase/ execution of sale deed of the same. However, he had also submitted information about its allotment earlier in offline mode, retained in his Misc. file.

Under the facts & details mentioned above and as the officer has purchased the flat from Government Organisation/ a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Saral Srivastava, Administrative Judge, Aligarh also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P.
