

**Ld.Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 29.08.2023 of Sri Bhagat Singh, Additional Chief Judicial Magistrate, Baghpat requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 33862023. In view of the above, Sri Bhagat Singh, aforesaid, has furnished his duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification as well as documents related to the University and letter of permission for pursuing LL.M. Degree course, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Sri Bhagat Singh, aforesaid has completed his two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.03.2023 thus, the said qualification may be included in his service records, as prayed for.

An objection dated 28.08.2023 was raised by this office regarding furnishing the attested copies of LL.M. credentials and the recognition of the university as well as approval of LL.M. course through distance learning mode & in reply, he has furnished the desired documents as well as clarification/supporting documents by attachment dated 05.09.2023 here on this portal.

In connection with the above, it is submitted that Sri Bhagat Singh, aforesaid, joined the U.P. Judicial Service on 17.04.2015, initially as Civil Judge(Junior Division), Kasganj. Further, it is relevant to mention here that Sri Bhagat Singh, aforesaid, pursued her two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2020-2022, after joining the judicial service with prior approval of this court, the letter of permission so obtained has been furnished by attachment dated 19.08.2023.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Bhagat Singh, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 19.08.2023 of Sri Bhagat Singh, Additional Chief Judicial Magistrate, Baghpat to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Baghpat for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Bhagat Singh, Additional Chief Judicial Magistrate, Baghpat may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
