May kindly see the online requisition dated 20.08.2023 of Sri Nitivan Nigam, Additional Civil Judge(Senior Division)/ACJM, Prayagraj requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 33892023. In view of the above, Sri Nitivan Nigam, has furnished his duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification as well as documents related to the University and letter of permission for pursuing LL.M. Degree course, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Sri Nitivan Nigam, aforesaid has completed his two-year LL.M. degree course in the year 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Haryana on 31.03.2023 thus, the said qualification may be included in his service records, as prayed for.

In connection with the above, it is submitted that Sri Nitivan Nigam, joined the U.P. Judicial Service on 13.01.2017, initially as Judicial Magistrate, Shahjahanpur. Further, it is relevant to mention here that Sri Nitivan Nigam, pursued his two-year LL.M. degree course from Kurukshetra University, Kurukshetra, Haryana in the year 2020-2022, after joining the judicial service with due approval of this court, the letter of permission so obtained has been furnished by attachment dated 20.08.2023.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Nitivan Nigam, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 20.08.2023 of Sri Nitivan Nigam, Additional Civil Judge(Senior Division)/ACJM, Prayagraj to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Allahabad/Prayagraj for Her Lordship's kind perusal and order to the effect that a copy of his online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Sri Nitivan Nigam, Additional Civil Judge(Senior Division)/ACJM, Prayagraj may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
