May kindly see the online application/ request dated 23.08.2023 of Sri Amit Veer Singh, the then Additional District & Sessions Judge, Sonbhadra, presently posted as Additional District Judge(POCSO), Sonbhadra, whereby he has requested for inclusion of his LL.M. qualification in his service records.

Sri Amit Veer Singh, in his application, has submitted that vide this Hon'ble Court's prior approval, he has been granted permission to take admission and pursue LL.M. Course through Kurukshetra University, Haryana and he successfully pursued LL.M. distance learning course/program in Dec, 2022 from Kurukshetra University, Haryana and would like to add this educational achievement in his Service Record. He has, therefore, requested for addition of LL.M. Degree in Service Record.

In support of the same, Sri Amit Veer Singh has furnished copies of recognition-related papers of the University (from attachment sl. no. 3-5), his LL.M. credentials comprising attested copies of Mark-sheets of both the years and degree and the copy of online permission of this Court regarding grant of earlier permission (at attachment sl. no. 2).

In this context, it is submitted that Sri Amit Veer Singh, aforesaid joined the U.P. Judicial Service on 15.06.2006 as Additional Civil Judge(Junior Division), Bulandshahar. Besides, as evident from submitted attested copies of Mark-sheets of both the years and the Degree qualification of LL.M., he has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the examination year May 2022 for LL.M. II (final years) as well as for 1st & 2nd year's back paper, whose examination was carried out in the same span of time by the University and due to which, there's a common date of result (i.e. Dec. 10, 2022) and the final year Mark-sheet issued on 16th Jan, 2023.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Amit Veer Singh, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/request dated 23.08.2023 of Sri Amit Veer Singh, the then Additional District & Sessions Judge, Sonbhadra, presently posted as Additional District Judge (POCSO), Sonbhadra may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Saurabh Srivastava, Administrative Judge, Sonbhadra for His Lordship's kind perusal and if His Lordship approves, a copy of online application/request dated 23.08.2023 of Sri Amit Veer Singh, the then Additional District & Sessions Judge, Sonbhadra, presently posted as Additional District Judge(POCSO), Sonbhadra along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of his form of U.P. Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in his service records?
