May kindly see the online requisition dated 25.08.2023 of Sri Praveen Singh, the then Additioinal Civil Judge(Junior Division), Auraiya, presently posted as Civil Judge(Junior Division), Auraiya requesting for inclusion of his Ph.D. Degree in his service records & addition of prefixing the word "Dr." before his name vide Case Id. No. 34042023. In view of the above, Sri Praveen Singh, has furnished his duly attested scanned copy of the Degree Qualification, as supporting document for the same.

An objection dated 12.09.2023 was raised by this office and in reply, Sri Praveen Singh, aforesaid has furnished the attested copy of desired document by attachment dated 13.09.2023. Further, another objection dated 07.10.2023 was raised by this office asking him to clarify the fact that whether he has completed the said course for the year 2019 before joining the U.P. Judicial Service & in reply, he made his submission dated 07.10.2023 clarifying that he has completed the course before joining the Judicial Service.

In this connection, it is submitted that Sri Praveen Singh, aforesaid, joined U.P. Judicial Services on 19.11.2019 as Metropolitan Magistrate, Kanpur. Besides, as evident from his submitted attested copy of his degree of Ph.D., Sri Praveen Singh, was awarded the degree of Doctor of Philosophy (Ph.D.) in the department of Law for the topic "Competition Commission in India: A Comparative Study with Special Reference to Developing Countries " in the year 2019 from Banaras Hindu University, Varanasi before joining the U.P. Judicial Service and was subsequently awarded Ph.D. Degree on 16.03.2021.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of Ph.D. Degree may be included in his service-records & prefixing word "Dr." be added before the name of Sri Praveen Singh, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online application dated 25.08.2023 of Sri Praveen Singh, the then Additioinal Civil Judge(Junior Division), Auraiya, presently posted as Civil Judge(Junior Division), Auraiya may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Manish Kumar Nigam, Administrative Judge, Auraiya, for His Lordship's kind perusal and approval to the effect that a copy of aforesaid letter dated 25.08.2023 (received online) along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Sri Praveen Singh, the then Additioinal Civil Judge(Junior Division), Auraiya, presently posted as Civil Judge(Junior Division), Auraiya may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
