May kindly see the online requisition dated 29.08.2023 of Smt. Ritika Tyagi, Additional District Judge(F.T.C.), Bulandshahar requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 334212023. In view of the above, Smt. Ritika Tyagi, aforesaid, has furnished her duly attested scanned copies of LL.M. Mark-sheets of two years and of the Degree Qualification, as supporting documents for the same.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets and of the Degree Qualification, Smt. Ritika Tyagi aforesaid has completed her two-year LL.M. degree course in the year 2012 and was subsequently awarded Degree from Hemwati Nandan Bahuguna Garhwal University, Uttarakhand on 02.08.2023 thus, the said qualification may be included in her service records, as prayed for.

Several objections dated 14.09.2023 were raised by this office regarding furnishing the attested copies of LL.M. credentials & clarification with respect to issuance of the degree certificate after a long gap in 2023 though the course was completed in 2012 & in reply, she has furnished the desired documents as well as clarification/ supporting documents by attachment dated 15.09.2023. Further, an objection dated 20.09.2023 was raised asking her to furnish the documents all in sequence and in vertical position & in reply, she furnished the desired documents by attachment dated 20.09.2023, here on this portal.

In connection with the above, it is submitted that Smt. Ritika Tyagi, aforesaid, joined the U.P. Judicial Service on 25.03.2021, initially as Additional District & Sessions Judge, Bulandshahar. Further, it is relevant to mention here that Smt. Ritika Tyagi, aforesaid, pursued her two-year LL.M. degree course from Hemwati Nandan Bahuguna Garhwal University, Uttarakhand in the year 2010-2012, prior to joining the U.P. Judicial Service.

further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Smt. Ritika Tyagi, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid online requisition dated 19.08.2023 of Smt. Ritika Tyagi, Additional District Judge(F.T.C.), Bulandshahar to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahar for His Lordship's kind perusal and order to the effect that a copy of her online requisition along with the copy of mark-sheets and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Nyayik Sewa of Smt. Ritika Tyagi, Additional District Judge(F.T.C.), Bulandshahar may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter.
