May kindly see the online requisition dated 30.08.2023 of Sri Sanjay Singh-II, Dy. Secretary, UP State Legal Services Authority, Lucknow, whereby he has requested for inclusion of his LL.M. qualification in his service records. In support of the same, Sri Sanjay Singh-II has furnished his LL.M. credentials comprising attested copies of Mark-sheets of 1st Year dated 05.03.2022 & reissued on 22.01.2023 and 2nd year marksheet dated 16.01.2023 & reissued on 16.06.2023, as well as Degree Qualification along-with a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and its enclosures letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting papers for inclusion of the aforesaid degree in his service record.

In this connection, it is pertinent to mention here that Sri Sanjay Singh-II, in his application has submitted that he has pursued the above-mentioned LL.M. course after joining the service on being granted the permission of this Hon'ble Court to pursue the said LL.M. course, the letter of permission so obtained has been provided by attachment dated 30.08.2023.

In this context, it is submitted that Sri Sanjay Singh-II, aforesaid joined the U.P. Judicial Service on 19.03.2015 as Additional Civil Judge (Junior Division), Ayodhya. Besides, as evident from submitted attested copies of Mark-sheets of both years and the Degree qualification of LL.M., he has completed two year LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra, Harayana on 31.07.2023, for the examination year 2022. Further he has submitted that he reappeared in 01 subject of 1st year exam & also applied for re-evaluation of 01 subject of 2nd year exam to improve his marks, therefore the marksheets were reissued on 22.01.2023 & 16.06.2023 respectively, thus the said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers, is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sri Sanjay Singh-II, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 30.08.2023 of Sri Sanjay Singh-II, Dy. Secretary, UP State Legal Services Authority, Lucknow, may be sent to the Government of U.P. for obtaining necessary orders.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow, for His Lordship's kind perusal and order to the effect that a copy of his online requisition along with copy of Mark-sheets (both years) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Sri Sanjay Singh-II, Dy. Secretary, UP State Legal Services Authority, Lucknow, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in the instant matter ?
