May kindly see the online application of Sri Anshuman Yadav, Registrar Land Aqai, Rehab & Resettlement Auth., Varanasi who joined service on 29.11.2019, drawing gross salary of Rs. 1,08,085/- & take home salary of Rs. 99,085/- regarding information about purchase of a new Kia Seltos, allotted reg. no. UP32 NS8655 (Copy of RC can be seen as attachment namely- R.C of the car), in the name of his father, intimated through application dated 04.09.2023.

Through his application, Sri Anshuman Yadav has submitted information about purchase of a new car on 20.06.2023 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Skydac Auto and Infra Pvt. Ltd., Krishna Nagar, Kanpur Road, Lucknow for Rs. 13,75,000/- in total (Copy of Tax invoice can be seen as attachments namely- Sale Receipt and Delivery Certificate), source of money of which is that Rs. 12,00,000/- has been taken as loan from State Bank of India, Lucknow, repayable in 84 monthly EMIs of Rs. 19,368/- (copy of 'loan arrangement letter' can be seen as attachment namely- loan sanction letter), Rs. 1,75,000/- (Rs. 1,65,000 Rs. 10,000/-) is stated to have been paid out of his saving bank account (copy of statement of his A/c can be seen as attachment namely- Bank Salary Statement). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court.

It is pertinent to mention here that the officer has received an amount of Rs. 1,75,000/- as a gift from his grandmother (nani) (Copy of 'consent letter' and saving bank A/c of his grandmother can be seen as attachment )

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Varanasi also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Varanasi for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
