May kindly see the online application of Sri Kunvar Mallikarjun, Registrar, Land Aqui., Rehab & Resettlement Authority, Prayagraj regarding grant of permission for submission of Ph.D. thesis to University of Allahabad

In his application, Sri Kunvar Mallikarjun has stated that he is enrolled and pursuing Ph.D. (Law) course from Faculty of Law, University of Allahabad, with effect from 02.08.2017 having enrollment number 2016AU/2459 and has completed the residential period (the period for which attendance is required in University for completing Ph.D. Course) and also qualified the Ph.D. course work exam as per the rules and regulations of University of Allahabad (copy of relating papers can be seen attachments). He has also stated that he is almost done with the research work of Ph.D. and now wishes to submit his Ph.D. thesis on the topic "Lok Swasthya Ka Adhikar Evam Cigarette Tatha Anya Tambakoo Utpad Adhiniyam 2003: Ek Aalochanatmak Adhyayan" in the supervision of Dr. J.P. Mishra, in near future and also assured that it would not affect in any manner his judicial work and he has also completed his Pre-doctoral Six months Ph.D. course work (copy of the letter can be seen as attchment). Thereafter through online objections, he has been asked to intimate his status of taking study leave and also about attendance requirement etc. In reply of the same the officer has stated that he do not require any study leave as he has already completed all the necessary requirements before joining this prestigious service and now only wants permission to submit his Ph.D. thesis and added that there is no physical day to day classes are required for pursuance and completion of the course. He has therefore, requested for grant of permission from the Hon'ble Court for submission of Ph.D. thesis to University of Allahabad.

In this connection, it is stated that the officer has joined the Uttar Pradesh Nyayik Sewa on 18.11.2019. There is a circular letter dated 4.11.11, which provides that if any Judicial Officer during the course of his Service, requests to pursue higher studies, he has to apply for grant of 'Study Leave' as per rules which will be subject to the discretion of Hon'ble the Chief Justice. In the instant case, the officer has stated that he has completed all the necessary requirements of his Ph.D. course work prior to his joining in this service and added that he do not require any study leave also. Now, It is on the discretion of the Hon'ble High Court either to grant permission to the officer for submission of his Ph.D. thesis or to pass any such order which deems to be proper.

Recently, vide order dated 30.11.2023 relating to re-constitution of Committees, Hon'ble The Acting Chief Justice has been pleased to change the single Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee, to deal with the matters relating to grant of permission to Judicial Officers to pursue academic course.

May, therefore, if approved, the file may be laid before single Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees, for His Lordship's kind perusal and if His Lordship approves:-

Mishra to University of Allahabad, as requested.
