May kindly see the online requisition dated 06.09.2023 of Sri Ravindra Prasad Gupta, posted on deputation post of Chief Legal Adviser, Noida, Gautambuddha Nagar, requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 34592023. In support of his application, Sri Ravindra Prasad Gupta furnished attested copies of LL.M. credentials comprising of LL.M. Marksheets of both the years and copy of Degree for inclusion of his qualification in the service records. Along with his LL.M. credentials, he has also furnished the permission letter, issued by Admin A-4 section vide Court's letter no. 5110/IV-3397/Admin.(A-4) dated 28.04.2021, to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra.

In this connection, it is submitted that Sri Ravindra Prasad Gupta, joined the U.P. Judicial Service on 15.06.2006 as Metropolitan Magistrate, Kanpur Nagar. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Sri Ravindra Prasad Gupta completed two years LL.M. course (from distance learning mode) in the year May 2022 and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the session May 2022, thus said qualification may be included in his service-records.

Therefore, it seems proper that aforesaid online requisition dated 06.09.2023 of Sri Ravindra Prasad Gupta, Chief Legal Adviser, Noida, Gautambuddha Nagar, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before the Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Gautambuddha Nagar, for His Lordship's kind perusal and order to the effect that a copy of his application along with copy of Mark-sheets (two years) and Degree of LL.M. (uploaded online on 06.09.2023) as well as attested copy of form of U.P. Nyayik Sewa of Sri Ravindra Prasad Gupta, Chief Legal Adviser, Noida, Gautambuddha Nagar, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter?
