

**Ld.Registrar (Judicial)(Budget)**

May kindly see the online requisition dated 06.09.2023 of Sri Abhinav Yadav-I, Chief Judicial Magistrate, Bijnor requesting for inclusion of LL.M. qualification in his service records vide Case Id No. 34602023. In support of his application, Sri Abhinav Yadav-I, furnished attested copies of LL.M. credentials comprising of LL.M. Mark-sheets of both the years and copy of the Degree qualification for inclusion of his qualification in the service records. Along with his LL.M. credentials, he has also furnished the permission letter, issued by this Court to pursue LL.M. through distance learning mode from Kurukshetra University, Kurukshetra as well as the documents related to the recognition of the University containing a letter dated 13.08.2018 of the Director, Directorate of Distance Education, Kurukshetra University, Kurukshetra and its enclosures letter no. F.No.122-1/2017(DEB-IV) Dated: 25.06.2018, as supporting papers for inclusion of the aforesaid degree in his service record.

In this connection, it is submitted that Sri Abhinav Yadav-I, joined the U.P. Judicial Service on 19.03.2015 as Additional Civil Judge (Junior Division), Pratapgarh. Besides, as evident from submitted attested copies of Mark-sheets (Two- years) and Degree of LL.M., Sri Abhinav Yadav-I, completed two year LL.M. degree course (from distance learning mode) in the year December 2022 after joining the Judicial Service & with due approval of this Court, copy of permission letter has been furnished hereon this portal by attachment dated 06.09.2023. Further, he was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the session May 2022, thus said qualification may be included in his service-records.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Sri Abhinav Yadav-I, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 06.09.2023 of Sri Abhinav Yadav-I, Chief Judicial Magistrate, Bijnor, may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Saurabh Lavania, Administrative Judge, Bijnor, for His Lordship's kind perusal and order to the effect that a copy of the application along with copy of Mark-sheets (two years) and Degree of LL.M. qualification as well as attested copy of form of U.P. Nyayik Sewa of Sri Abhinav Yadav-I, Chief Judicial Magistrate, Bijnor may be sent to the Joint Secretary, Appointment Section - 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
