May kindly see the online application received from Sri Sudeep Kumar Jaiswal, Additional District Judge (POCSO), Shahjahanpur regarding information about acceptance of gift money from his mother.

Sri Sudeep Kumar Jaiswal in his application has stated that his father Late V.K. Jaiswal was retired from the post of District Judge in the year 2005. His mother Smt. Vijay Luxmi Jaiswal has been getting family pension. Since, the death of his father, he and his family has been taking care of his mother. Presently, his elder daughter Shambhavi Jaiswal got selected and admitted to pursue her engineering course in Kalinga Insitute of Industrial Technology (KIIT), Bhubaneswar, Odisha. For this purpose, his mother (Smt. Vijay Luxmi Jaiswal) has gifted Rs 19,90,000/- for his daughter's educational fee from her Central Bank A/c no. 3016756832 through four transactions on various dates to his SBI account, out of natural love and affection. (Copy of gift deed, statement of A/c of the officer as well as his mother can be seen as attachment). It is therefore, requested that the information regarding acceptance of gift money may be placed before Hon'ble Court for kind perusal.

It is also submitted that the relevant rule relating to gift (Rule 11 of the U.P. Government Servant's Conduct Rules, 1956) runs as under:

11. Gifts:-A government servant shall not without previous approval of Government :-

(a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or

(b) Permit any memberComplete & attested copy of passbook of her S.B. A/c by indicating the particular entry/entries of payment made against the purchase of car and by disclosing the source of money deposited/credited to his account, in case any such credit exceeds the amount of her one month's salary of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.

It is further submitted that as the money had been gifted by the mother of the officer to him out of natural love and affection and is the closest blood relative being mother and son. Thus, there seems to be nothing objectionable as per rule referred to above.

May, therefore, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Shahjahanpur, also nominated for 'Disposal of the matters of the Judicial Officers, wherein permission/ information for sale or purchase of movable/ immovable property and permission/ information to accept gift under U.P. Government Servants' Conduct Rules 1956" for the district Shahjahanpur for His Lordship's kind perusal and information under Rule (11) of U.P. Government Servant's Conduct Rules, 1956?
