May kindly see the online requisition dated 14.09.2023 of Smt. Parul Kumari, Civil Judge(Junior Division), Sonbhadra requesting for inclusion of LL.M. qualification in her service records vide Case Id No. 34932023. In support of her application, Smt. Parul Kumari has furnished attested copies of LL.M. credentials comprising LL.M. Mark-sheets of all four semesters and the copy of Degree Qualification, as supporting documents for inclusion of qualification in her service records.

In this connection, it is submitted that Smt. Parul Kumari, joined the U.P. Judicial Service on 17.12.2019 as Civil Judge (Junior Division), Bareilly. Besides, as evident from submitted attested copies of Marksheets (Four- semesters) and Degree of LL.M., Smt. Parul Kumari completed two year LL.M. degree course in the year March 2020 with due permission of this Court in the middle of the course after joining the Judicial Service. The copy of permission letter so obtained has been furnished by attachment dated 14.09.2023 under the heading "Approval of Hon'ble High Court" & was Subsequently awarded the degree from Chaudhary Charan Singh University, meerut for the session 2020. Several objections 27.09.2023, 28.09.2023 & 07.11.2023 were raised by this office asking her to provide the necessary documents and clarification with regard to ambiguity in dates of issuance of marksheets & degree gualification & further, In reply thereto, she has furnished the desired documents by attachment dated 28.09.2023 & 07.11.2023. and necessary clarification by submission dated 20.10.2023, hereon this portal.

It is further submitted that appointing authority of Judicial Officers is the Government of U.P., thus qualification of LL.M. Degree may be included in the service records of Smt. Parul Kumari, aforesaid with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online requisition dated 14.09.2023 of Smt. Parul Kumari, Civil Judge (Junior Division), Sonbhadra may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Chandra Kumar Rai, Administrative Judge, Sonbhadra, for His Lordship's kind perusal and order to the effect that a copy of her application along with copy of Mark-sheets (four semesters) and Degree of LL.M. as well as attested copy of form of U.P. Nyayik Sewa of Smt. Parul Kumari, Civil Judge(Junior Division), Sonbhadra may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
