May kindly see the online application of Sri Harish Kumar-II Chief Judicial Magistrate, Lalitpur who joined service on 21.12.2009, drawing gross salary of Rs. 1,45,979/- & take home salary of Rs. 1,12,647/- regarding information about purchase of a new MG Hector car, allotted reg. no. UP 32MW 9002, intimated through application dated 18.09.2023.

Through his application, Sri Harish Kumar-II, has submitted information about purchase of a new car on 30.05.2022 by giving pointwise details as per Court's C.L. no. 25/Admin (A) dated 13.07.1998, according to which the car has been purchased by him from Beeaar auto wheels India Pvt. Ltd., Faizabad road, Chihat, Lucknow for Rs. 23,73,500/- in total, source of money of which is that Rs. 12,80,000/- has been taken as loan from State Bank of India, repayable in 83 monthly EMIs of Rs. 19,665/- (copy of 'loan arrangement letter' can be seen as attachment), Rs. 9,00,000/- is stated to have been paid through his saving account (copy of statement of A/c can be seen as attachment), Rs. 70,000/- is stated to have been paid as advance in cash (copy of invoice can be seen as attachment), Rs. 1,23,500/- is stated to have been paid in exchange of his old car (copy of 'delivery note' and 'vehicle sale details' can be seen as attachment). The dealer from whom the said car has been purchased by the officer is neither related to him in any way nor any case is pending/decided in his court. It is noteworthy to mention here that the officer has submitted the information regarding purchase of the aforementioned car after a delay of one year & has also apologized for the same. He was under the impression that he has submitted this statement with the property statement for the financial year 2021-23. Thus, the delay may kindly be condoned.

Under the facts & details mentioned above and as the officer has purchased the car from a regular & reputed dealer and has submitted sufficient details about purchase and source of money, if approved, the matter may kindly be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Lalitpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956", for the district Lalitpur for His Lordship's kind perusal and information under rule 24(2) of U.P. Government Servant's Conduct Rules, 1956?
