May kindly see the online application of Sri Anshuman Yadav, Registrar, Land Aqui, Rehab & Resettlement Authority, Varanasi regarding information about sale of his old Kia Seltos car, intimated through his application dated 20.09.2023.

In his application, Sri Anshuman Yadav has stated that he had purchased a Kia Seltos Car bearing registration number UP32 LU8705 (copy of RC can be seen as attachment namely- R.C of the sold car). The information regarding the purchase of the said car was earlier submitted before this Hon'ble Court (through e-portal case Id S00009552021). Then he has decided to sell it off. Thus, on 08.09.2023, he has sold his car to Vimal Car Bazar (Regular and Reputed dealer), Indira Nagar, Lucknow. The sale price of the said vehicle i.e. Rs. 8,25,000/- (copy of payment receipt can be seen as attachment namely- Car delivery Certificate), out of which 8,00,000/- was transferred to his account by the representative of Vimal Car Bazar (copy of statement of A/c can be seen as attachment namely- Bank of Baroda Passbook), and the remaning amount i.e., 25,000/- was transferred to his friend's account for conforming the sale of the car (which can be seen as attachment namely-UPI). The said amount has been used for closing the loan taken by him from Bank of Baroda, Ayodhya (copy of NOC of loan can be seen as attachment). The purchaser is neither related to him in any manner nor any of his case is decided or pending in his Court. The officer has therefore, intimated about the sale of his old car for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the officer has sold his car through a regular and reputed dealer. There seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Siddhartha Varma Administrative Judge, Varanasi also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Varanasii, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
