May kindly see the online application/ request no. S00035532023 dated 30.09.2023 of Sushri Saumya Dweivedi, Metropolitan Magistrate, Kanpur Nagar whereby she has requested for inclusion of her LL.M. qualification in her service records.

Sushri Saumya Dweivedi, in her application, has submitted that she has been granted permission from this Court to pursue the aforesaid LL.M. Course through Kurukshetra University, Haryana and she successfully pursued LL.M. distance learning course/program in Feb, 2023 from Kurukshetra University, Haryana and would like to add this educational achievement in her Service Record. She has, therefore, requested for addition of LL.M. Degree in Service Record.

Several objections dated 24.10.2023, 17.11.2023 & 05.01.2024 were raised by this office for attested copies of LL.M. credentials as well as clarification with regard to recognition of Kurukshetra University, Kurukshetra and approval of aforesaid LL.M. Course for the relevant years. In reply, she has furnished the desired documents & her submissions dt. 23.01.2024 relating to recognition of University backed up by supporting documents furnished by attachment dated 23.01.2024 (from sl. no. 11 to 14).

In support of her requisition, Sushri Saumya Dweivedi, has furnished copies of her LL.M. credentials comprising attested copies of Mark-sheets of both the years and degree (from sl. nos. 6 to 8) by attachment dated 24.10.2023, recognition-related papers of the University (from attachment sl. Nos. 11 to 14) by attachment dt.23.01.2024, copy of permission letter of this Court regarding grant of earlier permission (attachment sl. no. 1) by attachment dt. 30.09.2023.

In this context, it is submitted that Sushri Saumya Dweivedi, aforesaid joined the U.P. Judicial Service on 16.11.2019, as Additional Civil Judge(Junior Division), Ambedkar Nagar. Besides, as evident from submitted attested copies of Marksheets of both the years and the Degree qualification of LL.M., she has completed two years LL.M. course and was subsequently awarded Degree from Kurukshetra University, Kurukshetra on 31.03.2023 for the examination year May 2022 for LL.M. I year marksheet dated 09.02.2022 as well as for LL.M. final year marksheet dated 01.02.2023.

It is further submitted that the appointing authority of Judicial Officers is the Government of U.P., thus the said qualification of LL.M. Degree may be included in the service records of Sushri Saumya Dweivedi, aforesaid with the formal order of Government of U.P. to be issued in this regard. Therefore, it seems proper that the aforesaid online application/ request dated 30.09.2023 of Sushri Saumya Dweivedi, Metropolitan Magistrate, Kanpur Nagar may be sent to the Government of U.P. for obtaining necessary orders in this regard.

In view of the above facts, if approved, the matter may kindly be placed before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar for His Lordship's kind perusal and if His Lordship approves, a copy of online application/ request dated 30.09.2023 of Sushri Saumya Dweivedi, Metropolitan Magistrate, Kanpur Nagar along with copies of, Degree of LL.M. and Mark-sheets of both the years of LL.M. examination, as well as attested copy of her form of U.P. Judicial Service, may be sent to the Joint Secretary, Appointment Section – 4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. relating to inclusion of LL.M. degree in her service records?
