May kindly see the online application of Smt. Shaleen Mishra, Civil Judge (Junior Division), Sultanpur regarding grant of permission to visit Hong Kong along with her husband during the winter Holidays in the month of December, 2023 i.e. from 26.12.2023 to 31.12.2023.

In her application dated 05.10.2023, Smt. Shaleen Mishra has stated that she wishes to visit Hong Kong along with her husband during the winter Holidays in the month of December, 2023 to visit her sister in law who is a resident of Hong Kong. She has also stated that all the expenses of the officer would be borne from her salary (copy of passbook showing balance amount of Rs. 11,64,809/- can be seen as attachment) and during this period she would reside with her sister in law at her residence at Flat F, 5th floor, tower 6 ,Carribean Coast, man Tung road,Tung Chung Hong Kong. She has also submitted the following declaration:-

- 1- That by her abroad visit no dilemma is likely to be created before Government of India or Government of U.P.
- 2- That such type of request for aboard visit has not been refused earlier.
- 3- That she has visited Thailand in June 2023 after obtaining permission of the Hon'ble High Court.

Thereafter, through online objection dated 06.10.2023, the officer has been asked to intimate about the expenditure of the said visit. In her reply dated 06.10.2023, the officer has stated that the estimated expenditure for the tour would be around Rs. 1,00,000/- per person and that would be borne out of her salary account. She has, therefore, requested to grant her permission for the aforesaid visit in order to apply for visa /booking and initiate other formalities.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 and in accordance with Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017. As per reports, no vigilance/ departmental enquiry is pending against Smt. Shaleen Mishra. As per the point no. (1) of Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017, Abroad tour by any officer shall not be availed of during working days of the Hon'ble Court or during the period of suspension/departmental proceedings, except in case of medical treatment of himself/ herself, spouse or dependent, or in special circumstances, and tours which are sponsored and/ or approved by the State/ Central Government during certain fixed span of time and does not fall during vacation. In these eventualities the Judicial officers shall seek permission before applying for VISA. In the instant case the officer is going for this pleasure/ family trip in winter holidays i.e. from 26.12.2023 to 31.12.2023, thus her request appears to be considerable. Now its upto the discretion of Hon'ble The Chief Justice and Hon'ble Administrative Judge, Sultanpur either to grant her permission to visit alongwith her husband during the aforesaid period or to pass any other order. It is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Recently, vide order dated 23.04.2023 regarding reconstitution of different Committees, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to visit abroad

May, therefore, if approved, the instant matter may be laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Sultanpur for kind perusal and if His Lordship approves, Smt. Shaleen Mishra, Civil Judge (Junior Division), Sultanpur may be granted permission, to visit Hong Kong along with her husband during the winter holidays in the month of December, 2023 i.e. from 26.12.2023 to 31.12.2023, as requested, subject to approval by Hon'ble Mr. Justice Surya Prakash Kesarwani, Senior Judge (J-1), as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 23.04.2023 of Hon'ble the Chief

Justice, as mentioned above with the condition that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?

Or

To pass any other order, which His Lordship deems fit and proper.
