May kindly see the online requisition dated 05.10.2023 of Sri Anupam Goyal, Principal Judge, Family Court, Muzaffar Nagar requesting for addition of prefixing the word "Doctor" before his name vide Case Id. No. 35712023. In view of the above, Sri Anupam Goyal, has furnished his duly attested scanned copy of the Degree Qualification, as supporting document for the same.

An objection dated 06.10.2023 was raised by this office and in reply, Sri Anupam Goyal, aforesaid has furnished the attested copy of desired document by attachment dated 07.10.2023.

In this connection, it is submitted that Sri Anupam Goyal, aforesaid, joined U.P. Judicial Services on 15.12.2008 as Additional District & Sessions Judge, Mainpuri. Besides, as evident from his submitted attested copy of his degree of Ph.D., Sri Anupam Goyal, was awarded the degree of Doctor of Philosophy (Ph.D.) in the year 2002 from University of Delhi, Delhi before joining the U.P. Judicial Service and was subsequently awarded Ph.D. Degree on 22.02.2002 & the aforesaid degree has been mentioned in the form of U.P. Judicial Service, also the same has been included in his service record & is displaying on the portal as well as on website.

Further, it is submitted that appointing authority of Judicial Officers is the Government of U.P., thus prefixing the word "Doctor" be added before the name of Sri Anupam Goyal, aforesaid, with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid online application dated 05.10.2023 of Sri Anupam Goyal, Principal Judge, Family Court, Muzaffar Nagar may be sent to the Government of U.P. for obtaining necessary orders.

If approved, the matter may kindly be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Muzaffar Nagar, for His Lordship's kind perusal and approval to the effect that copy of aforesaid online application dated 05.10.2023 along with attested copy of Ph.D. Degree as well as attested copy of form of U.P. Nyayik Sewa of Sri Anupam Goyal, Principal Judge, Family Court, Muzaffar Nagar, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government of U.P. in instant matter ?
