May kindly see the online requisition/ case id No.S00035822023 dated 07.10.2023 of Sri Pravin Kumar Yadav, Nyayadhikari Gram Nyayalaya, Swar, Rampur whereby he has requested for inclusion of his LL.M. qualification in his service records.

In support of the same, Sri Pravin Kumar Yadav, has furnished his duly attested scanned copies of LL.M. Mark-sheets (all semesters as well as Consolidated) and of the Degree Qualification as well as copy of online permission letter of this Court to pursue the aforesaid course as supporting documents for the same.

An objection dated 13.03.2024 was raised by this office with respect to submitting the copy of permission letter of this Court to pursue the aforesaid Course & in reply, he has submitted the copy of desired document by attachment dated 16.03.2024.

In the connection, it is submitted that Sri Pravin Kumar Yadav, joined the U.P. Judicial Service on 16.12.2019, initially as Additional Civil Judge(Junior Division), Jaunpur. Further, it is relevant to mention here that Sri Pravin Kumar Yadav, pursued his LL.M. course for the session 2018-2020, from University of Allahabad, Allahabad with due permission of this Court (copy furnished by attachment at sl. no. 2) in the middle of the course after joining the U.P. Judicial Service.

In addition to the above, as evident from submitted attested copies of LL.M mark-sheets (all semesters) and copy of the Degree Qualification, Sri Pravin Kumar Yadav, completed his two-year LL.M. degree course in the year 2020 and was subsequently awarded Degree from University of Allahabad, Allahabad on 08.11.2021, thus the said qualification may be included in his service records.

Further, It is submitted that the Government of U.P. is the appointing authority of Judicial Officers, therefore, the qualification of LL.M. Degree may be included in the service records of Sri Pravin Kumar Yadav, aforesaid with the permission of Government of U.P., Lucknow. Hence, it seems proper to send the aforesaid requisition dated 07.10.2023 of Sri Pravin Kumar Yadav, Nyayadhikari Gram Nyayalaya, Swar, Rampur to the Government of U.P. in order to obtain necessary orders.

If approved, the matter may kindly be placed before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Rampur for His Lordship's kind perusal and if His Lordship approves a copy of his online requisition along with the copy of mark-sheets (four semesters as well as consolidated) and of the Degree qualification of LL.M. as well as the attested copy of form of U. P. Judicial Service of Sri Pravin Kumar Yadav, Nyayadhikari Gram Nyayalaya, Swar, Rampur may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. Lucknow, for obtaining necessary order of the government of U.P. in the instant matter relating to inclusion of LL.M. Degree Qualification in the service records.
