

## **Registrar (J) Budget)**

May kindly see the online application of Smt. Garima Singh-I, Additional District & Sessions Judge, Shahjahanpur regarding information about sale of old Hyundai i-20 sportz car, intimated through her application dated 01.11.2023.

Through her application, Smt. Garima Singh-I has stated that she has purchased the vehicle bearing registration no. UP81 CJ6501 on 12.12.2019 from M/S Shiva Auto Sales, Aligarh (copy of RC can be seen as attachment). The aforementioned car was approx four year old and was not useful for the officer. On dated 11.09.2023, she has purchased a new Kia Carens Prestige car from M/S Ambay Autocars Private Limited, Bareilly. The Information regarding purchase of new car has already been submitted by the officer to Hon'ble Court (Case Id S00035962023). Then she has decided to sell her old car. Thus, on 10.10.2023, she has sold her car to TRUE VALUE (Sumitra DS Motors Private Limited, Shahjahanpur) for Rs. 5,00,000/- through regular & registered dealer (copy of 'purchase letter' can be seen as attachment). The sale price of the said vehicle i.e. Rs. 5,00,000/- is stated to have been transferred by Sumitra DS Motors Private Limited to the officer's A/c (copy of passbook can be seen as attachment). The purchaser is neither related to her in any manner nor any of his case is decided or pending in her Court. The officer has therefore, intimated about the sale of her old said car for kind perusal of this Hon'ble Court.

In this connection, it is submitted that the officer has sold her car through a regular and reputed dealer. There seems to be nothing objectionable as per the Rule-24 (2) of U.P. Government Servant's conduct Rules, 1956, which is as follows:-

24 (2):- "A Government servant who enters into any transaction concerning any movable property exceeding in value, the amount of his basic pay for one month, whether by way of purchase, sale or otherwise, shall forthwith report such transaction to the appropriate authority;

Provided that no Government servant shall inter into any such transaction except with or through a reputed dealer or agent of standing, or with the previous sanction of the appropriate authority."

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Kumar Singh, Administrative Judge, Shahjahanpur also nominated for "Disposal of the matters of the Judicial Officers wherein permission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P. Government Servant's Conduct Rules, 1956" for the District Shahjahanpur, for His Lordship's kind perusal and information under Rule 24 (2) U.P. Government Servant's Conduct Rules, 1956?
