May kindly see the online office note dated 08.11.2023, upon which Hon'ble the Administrative Judge, Jaunpur vide His Lordship's order dated 30.11.2023 has been pleased to grant permission to Smt. Shwetsa Chandra, Addl. Civil Judge (Senior Division)/ACJM, Jaunpur to visit Dubai along with her husband Sri Vivek Vikram who is also a Judicial Officer, and her parents, from 23.12.2023 to 31.12.2023 for tourism purpose, as requested.

In this connection it is also submitted that in the Hon'ble High Court's Circular Letter dated 27.05.2017, it has been settled that for the purpose of grant of such permission the competent authority for the judicial officers is Hon'ble the Administrative Judge of the District concerned, for the Judicial officers posted in judgeship or on the District of any deputation post, subject to approval by Hon'ble the Chief Justice or any member of the Administrative Committee authorised by the Hon'ble the Chief Justice. Earlier, vide order dated 23.04.2023 regarding reconstitution of different Committees- Last modified on 29.08.2023, Hon'ble The Chief Justice has been pleased to form a single Hon'ble Judge Committee i.e. Hon'ble Senior Judge (J-1) to deal with the matter of grant of permission to Judicial Officers to visit abroad and accordingly, the permission granted in this case vide order dated 30.11.2023 of Hon'ble the Administrative Judge, Jaunpur was submitted before Hon'ble Mr. Justice Manoj Kumar Gupta, Hon'ble The Acting Chief Justice/ Hon'ble Senior Judge (J-1) for His Lordship's kind approval. But, recently vide order dated 30.11.2023 relating to re-constitution of Committees, Hon'ble The Acting Chief Justice has been pleased to change the single Hon'ble Judge Committee appearing at sl. no. 3 of the list of Committees dated 23.04.2023- last modified on 29.08.2023, and Hon'ble Mr. Justice Anjani Kumar Mishra is nominated in the said Committee to deal with the matters relating to grant of permission to Judicial Officers to visit abroad. In compliance with the order dated 30.11.2023, the matter is reverted to the office and is now likely to be placed before Hon'ble Mr. Justice Anjani Kumar Mishra.

Under the facts and circumstances mentioned above, if approved, the file may kindly be laid before single Hon'ble Judge Committee of Hon'ble Mr. Justice Anjani Kumar Mishra, as per Hon'ble High Court's Circular Letter No. 16/ IV-f-101/ Admin (A)/ dated 27.05.2017 and order dated 30.11.2023 of Hon'ble The Acting Chief Justice relating to re-constitution of Committees, for His Lordship kind perusal and approval of His Lordship for grant of permission to Smt. Shwetsa Chandra, Addl. Civil Judge (Senior Division)/ACJM, Jaunpur to visit Dubai along with her husband Sri Vivek Vikram who is also a Judicial Officer, and her parents, from 23.12.2023 to 31.12.2023 for tourism purpose, as requested and as already permitted/ approved by Hon'ble the Administrative Judge, Jaunpur Judgeship, subject to the conditions that proper charge of Government records or cash, if any, or any government property with her, may be handed over by her before proceeding abroad?
