May, therefore, if approved, the matter be laid before Hon'ble Mr. Justice Nalin Kumar Srivastava, Administrative Judge, Etah, also nominated for "Disposal of the matters of the Judicial Officers, whereinpermission/information for sale or purchase of movable/immovable property and permission/information to accept gift under U.P.
